CALL TO ORDER / ROLL CALL FOR CAUCUS MEETING

EXECUTIVE SESSION

This exception shall not be interpreted to permit discussion of general personnel matters in secret. Second to the motion was offered by Commissioner Fennell. Upon hearing there were no questions, the mayor called for a roll call vote.
